

## **RMPP (Unpaid Toll Report) Payment Information**

### **Information pursuant to Article 13 of European Regulation 2016/679**

#### **1. DATA CONTROLLER**

Pursuant to current privacy legislation (art.13 of European Regulation 2016/679 of the "GDPR"), please find below the information on the processing of personal data provided for the online payment of "Unpaid Toll Report", as well as for those provided for the request for the invoicing of the payment itself; such data are collected and may be used and processed, in hard copy and electronically, through their employees in charge of processing and for the sole purposes related to the management of the payment by the following motorway concessionaire companies, each for the sections under their jurisdiction, in their capacity as independent data controllers:

Personal data will also be collected by CartaSì, in its capacity as independent Data Controller, for the purpose of charging the amount of the toll due to the above-mentioned Concessionary Companies for the transits along the routes under their jurisdiction.

#### **2. TYPES OF DATA PROCESSED**

The data processed by the Companies mentioned in point 1. include common data.

#### **3. PURPOSE AND LEGAL BASIS OF THE PROCESSING**

The data shall be processed for the purpose of online payment of the "Unpaid Toll Report", processing of the payment receipt and/or the production and dispatch of any invoices requested.

The legal basis for the processing, pursuant to art. 6(1)(b) and (c) of the GDPR, is: i) performance of the contract; ii) legal obligation.

The provision of data is mandatory for the aforementioned payment activities of the "Online Unpaid Toll Report", for the processing of the payment receipt and/or for the production of the invoices possibly requested; therefore, failure to provide/partial or inaccurate provision of data may result in the impossibility of carrying out these activities.

#### **4. DATA PROCESSING METHODS**

Personal data will be processed, in compliance with the regulations in force, through manual, IT and telematic tools and by implementing procedures strictly related to the aforementioned purposes, so as to ensure the confidentiality and security of the data.

#### **5. DATA RETENTION PERIOD**

Personal data will only be stored for as long as necessary for the purposes for which they are collected in compliance with the principle of minimisation pursuant to art. 5(1)(c) of the GDPR.

#### **6. DATA RECIPIENTS**

Within the companies referred to in point 1 above, only the persons tasked with the processing by the Data Controller and authorised to perform the processing operations within the scope of the aforementioned activities may acquire the personal data provided.

Personal data may be disclosed to third parties (parent/subsidiary companies involved or third-party companies) who are required to process the information for the same purposes as set out in point 3, and which are, for this purpose, appointed as "Data Processors".

The administrative activities relating to the online payment service, and, specifically, the processing of the payment receipt and the production and dispatch of any invoices requested, are carried out on behalf of the motorway concessionaire companies by EsseDiEsse Società di Servizi S.p.A., with registered office in Rome, Via A. Bergamini 50, 00159, Rome, appointed for this purpose as Data Processor by the Concessionaires.

The activities of IT hosting and online management of the Unpaid Toll Report are carried out on behalf of the above motorway concession companies by: - Autostrade per l'Italia S.p.A., with registered office in Rome Via A. Bergamini 50, 00159 Rome, appointed as Data Processor for this purpose. The full list of the persons appointed as Data Processors is available from the DPOs.

Under no circumstances will personal data be disseminated.

#### **7. RIGHTS OF DATA SUBJECTS**

Articles 15-22 of European Regulation no. 679/2016 allow Data Subjects to exercise specific rights; Data Subjects may obtain from the Data Controller: access, correction, cancellation, restriction of processing, revocation of consent as well as portability of data concerning them.

Data Subjects may also object to the processing. Where the Data Subject exercises the right to object to the processing, the Data Controller reserves the right not to process the request, and thus to continue processing, if there are compelling legitimate grounds for processing that prevail over the interests, rights and freedoms of the Data Subject.

The aforementioned rights may be exercised by making a request addressed without formalities to the Data Protection Officer (DPO) at the following addresses:
