**Privacy Policy Statement as defined in accordance with Article 13 of Legislative Decree 196/03
(Privacy Code)**

1. In accordance with Article 13 of Legislative Decree 196/2003, you are hereby informed that personal data supplied by you in relation to the on-line payment for a "Non-payment of Toll Report", as well as those included on your invoice request have been filed and can be processed (electronically and in paper form) by staff for the sole purposes of finalising the payment process. The following franchises are licensed to manage payments issues for the relevant routes:

- Autostrade per l'Italia S.p.A., Via A. Bergamini 50, 00159 Rome;
- Raccordo Autostradale Valle d'Aosta S.p.A., Via A. Bergamini 50, 00159 Rome;
- Società Autostrade Meridionali S.p.A., Via Giovanni Porzio 4 - Centro Direzionale Is. A/7 - 80143 Naples;
- Società Autostrada Tirrenica S.p.A., Via A. Bergamini 50, 00159 Rome;
- Strada dei Parchi S.p.A., Via G.Bona 105, 00156 Rome;
- Tangenziale di Napoli S.p.A., Via Giovanni Porzio 4 - Centro Direzionale Is. A/7 - 80143 Naples;

2. The aforementioned personal data is also collected and processed by CartaSi, in relation to payment of tolls due to the highway franchise directly concerned (see Point 1).

Processing of personal data can also be carried out by third parties, who the highway franchises (Point 1) have contracted for the purposes of finalising the on-line payment of "Non-payment of Toll Reports". In this case, the subjects involved are deemed legally responsible for said data processing. Said third parties, will be issued with the relevant operative instructions by the highway franchises, with specific reference to minimum security levels, aimed at ensuring privacy and data security.

In particular, processing of payment receipts and invoices, is carried out individually on behalf of the highway franchises (see Point 1) by:

- EsseDiEsse Società di Servizi S.p.A., Via A. Bergamini 50, 00159 Rome – for these purposes authorised to process the data.

On the other hand, data housing and management of on-line requests for "Non-payment of Toll Reports" are carried out by:

- Autostrade per l'Italia S.p.A., Via A. Bergamini 50, 00159 Rome – for these purposes authorised to process the data.

3. Save as expressly provided by Point 2, personal data which has been gathered and stored in the data banks of the highway franchises, is not subject to distribution, or transmission, save for those cases mentioned in the law and by means of the appropriate procedures.

4. The supply of personal data is obligatory in order to finalise the above matters, failure to provide data, or the supply of partial or incorrect data could result in the failure of the payment procedure for a "Non-payment of Toll Report".

5. You may address the relevant highway franchise (see Point 1) in order to exercise your rights in accordance with Article 7 of D.Lgs 196/03 (notification of updates, modification of data, request information on processing methods and aims, obtain detailed information on the Franchise, obtain the cancellation of data processed in violation of the law, etc.).

The personal data supplied will be kept for the period of time deemed necessary to finalise the payment process, in accordance with the relevant legislation naturally.
